## **Terms and Conditions**

**1. Definitions**: "Event" refers to G-FEST, scheduled to be held July 11, 12, and 13, 2025, at the Hyatt Regency O'Hare in Rosemont, IL. "Organizer" refers to Daikaiju Enterprises Ltd. and its officers and representatives. "Exhibitor" refers to any company, business entity, or person that is applying for exhibit space as agreed to in this contract and upon acceptance by the organizer.

**2. Exhibit Set-up/Break-down**: The Organizer shall provide access to the exhibit area at approximately 10:00 AM on the day before the start of the event on Friday, July 12, and for two hours following the event on July 17, 2023.

**3. Inappropriate Materials:** G-FEST is a family-friendly show. No pornographic, vulgar, violent, or weapons-related materials of any kind will be allowed in the exhibit area. No mechanically reproduced item bearing the likeness of any copyrighted or trademarked character that is not licensed for sale in Japan or North America, nor any unauthorized/unlicensed copy of video material, may be sold or offered for sale. The exhibitor agrees to remove any materials at the discretion of the organizer or will forfeit their exhibit space without refund. If this issue occurs more than once, or is a particularly blatant violation the organizer reserves the right to immediately revoke the exhibitor's space without a refund, even if the exhibitor agrees to remove the offending materials. Artists wishing to sell reproductions of their work that include trademarked or copyrighted characters are encouraged to contact the appropriate copyright/trademark owner to acquire a temporary license.

**4. Taxes, Licenses, Insurance**: Exhibitor agrees to obtain any necessary licenses and/or permits applicable to its activities at the event. Exhibitor agrees to obtain any necessary tax identification numbers and to pay any appropriate taxes due any government authority. Exhibitor will have copies of their licenses and/or permits, and tax identification numbers in their possession during the event, and to provide such for event Organizer's inspection upon request. Exhibitor agrees not to hold Organizer responsible for any losses due to theft, loss, harm, or injury. Exhibitor is individually responsible for securing insurance to protect against said losses.

**5. Exhibit Space Occupancy**: Exhibitor is responsible for the appearance of its exhibit area and shall remove trash at the close of each day. Exhibitor shall not interfere with the set-up or operation of any other exhibitors and will assure proper conduct by its representatives. Exhibitor is responsible for any damages caused by the Exhibitor while operating within its exhibit area. **Subletting of exhibit space is prohibited.** 

**6. Vendor Passes & Additional Passes:** Each Vendor will recieve two (2) vendor badges. Vendors are eligible to purchase one (1) additional badge per table rented at a reduced rate. Additional badges are non-transferable and may not be shared.

The allocation and purchase of badges shall adhere to the following structure:

- 1. Vendors renting two (2) tables will receive two (2) vendor badges and may purchase one (1) additional badge at a reduced rate, for a total of three (3) badges.
- 2. Vendors renting four (4) tables will receive two (2) vendor badges and may purchase two (2) additional badges at a reduced rate, totaling four (4) badges.
- 3. Vendors renting five (5) tables will receive two (2) vendor badges and may purchase three (3) additional badges at a reduced rate, totaling five (5) badges.
- **4.** Vendors renting six (6) tables will receive two (2) vendor badges and may purchase four (4) additional badges at a reduced rate, totaling six (6) badges.

Any requests for badges beyond the specified limits will be subject to the standard three-day event rate per badge. No additional helper badges will be available for purchase on-site at the convention; only standard three-day conventioneer badges will be offered. The reduced vendor badge rate is reflected in this contract and will be honored only upon the submission of the 2025 contract.

**7. Indemnification**: Exhibitor agrees to indemnify, defend, and hold the Organizer harmless for any and all claims, suits, liabilities, damages, losses, and attorney's fees and expenses which arise from participation in this event, any breach of this contract, or any matter for which the Exhibitor is responsible from this contract.

**8. Contract Acceptance and Refunds**: This contract shall become binding when returned by the Exhibitor and accepted by the Organizer along with payment in full. Your space will not be held until the Organizer has received payment in full. If requested ninety (90) days or more before the start of the event refunds of 50% of total event space will be granted. Refunds requested within 90 days of the event will not be granted.
